## The two primary drivers of cost for your co-op

**WHAT DRIVES COST** for electric utilities? Storms? Gas prices? The cost of labor? Environmental

regulations? Supply chain issues? Yes, all of those. However, the two main drivers of cost for your cooperative are meter density and load factor. This month, I want to share why they matter so much.

#### Meter density

A utility's meter density refers to how many meters, or customers, receive service from each mile of infrastructure. It is not unusual for a for-profit utility to have a meter density of 30 per mile. So, basically, there are 30 customers who share the cost of every mile of line that the utility must construct, operate and maintain.

Santee Electric Cooperative has a meter density of approximately eight per mile. That means the cost of constructing, operating and maintaining each mile of our power lines is spread between only eight of our member-owners.

Meter density is why electric cooperatives were created in the first place. Numerous utilities were already serving the densely populated portions of our country long before electric cooperatives were created. Electric cooperatives were tasked with going into the more sparsely populated areas where it was harder to realize a return on investment.

#### Load factor

Load factor is the ratio of your average demand to your peak demand. Basically, it measures the efficiency of your power consumption (not to be confused with the efficiency of your home). Think of a gym with workout equipment. The load factor would be the average number of people exercising throughout the day compared to the maximum number of people exercising at any given moment. If, on average, there are 25 people working out when the gym can accommodate 50, the

load factor is 50%. Peak demand occurs when the gym is busiest, reaching its maximum capacity, like during the afterwork rush hour.

I have stressed in recent issues how electricity is relatively inexpensive to purchase and deliver during off-peak hours and quite costly during peak hours. This ties in very closely with load factor.

#### What are we doing about it?

Since these two factors drive SEC's costs, they also affect your power bill. So, what, might you ask, is the cooperative doing to try to manage costs? On the load factor side, our new rate structure, as well as our smart thermostat and water heater switch programs, go a long way to help members lower their energy use, especially during peak periods.

Regarding meter density, your cooperative works hard with area developers to make it easy to build much needed homes in our service territory. After all, the cost of a mile of line is easier to bear when shared by ten members instead of only eight.

Santee Electric also is involved in economic development, which does more than just bring jobs and investment to our area. It also helps us manage costs. The industries that move into our service territory have large load factors because they typically buy as much electricity when it is inexpensive as when the system is peaking. Furthermore, the jobs that are created bring homeowners to the area, and that improves meter density.

Just know your cooperative is doing all we can to manage these two factors, and all others, of our costs.
