# National co-op month

1. Voluntary and Open

- 3. Members' Economic

  Participation: Cooperatives work on a revolving equity system. Starting with your initial membership fee and continuing on with annual margins, Santee Electric maintains a healthy equity level and then returns your portion to you as we retire capital credits.
- 4. Autonomy and Independence: While we may be part of state and national associations, there really is just one Santee Electric Cooperative. We are governed by you-the members-and you alone.
- 5. Education, Training, and Information: One of the major initiatives



I have tried to focus on since I arrived at SEC is our relationship with students-from having elementary school kids design our company Christmas cardsto offering career guidance to middle and high school students-to providing scholarships for college students. We care for our students at SEC!

6. Cooperation Among
